The Vice- Chancellor also explained the house about matter of promoting all lower/terminal semester UG and PG students of our university, based on the formula proposed by the Govt. of Karnataka, i.e. 50% weightage of performance in current semester Continuous Internal Exam (CIE) and 50% weightage of previous semester performance, was approved by both the Academic Council and the Board of Management in their meetings held on 20/07/2020.

Approval for starting a new PG Diploma in Data Science for Logistics program in the Faculty of Engineering and Technology of our University from the academic year 2020-2021.

The Vice-Chancellor briefed the august body about starting of new PG Diploma in Data Science for Logistics program in the faculty of Engineering and Technology of our University. As per the Logistics Sector Council (LSC), established by the Ministry of Skill Development and Entrepreneurship (MSDE), Govt. of India, through the National Skill Development Corporation of India (NSDC) has designed a new PG Diploma program in Data Science for Logistics, for addressing the huge requirements of trained manpower in the emerging fields of Logistics in India.

The Vice-Chancellor explained the house about two of such programs (I) BBA Logistics and (II) BMS Aviation Services and Air Cargo, have been already started by our University in collaboration with LSC, Govt. of India, after the approval of BOG in the seventh meeting,

The Vice-Chancellor also explained the house about PG Diploma in Data Science in Logistics program is apprenticeship based 18 months (3 Semesters) program, designed for BE/BTech. students. During the first two semesters the students will be studying in the university campus and the third and last semester every student has to undergo apprenticeship training in the industries. During the apprenticeship training all students will receive a stipend of Rs. 9000/- (Rs. Nine Thousand Only) per month for six months.

The Vice-Chancellor also explained the house that same was approved by both the Academic Council and the Board of Management in their meetings held on 20/07/2020.
